FEDERAL REGISTER: POSTAL SERVICE 39 CFR PART 111 – ADDRESS CORRECTION NOTICES

Effective July 9, 2023, the Postal Service is amending Mailing Standards of the United States postal Service, Domestic Mail Manual sections 507.4.2.6 and 705.23, to update information regarding address correction requests and to remove hardcopy address correction notice options for Full-Service and Seamless Acceptance mailers.

Mailers have been plagued by incorrect address information for decades. Amendments to the Domestic Mail Manual (DMM) Mailing Standards are coming on July 9, 2023, and mailers need to be prepared as there are concerns about the removal of hard-copy address correction notices and the complexity of the new regulations in general. A complete explanation of the new DMM Mailing Standards can be found in the Federal Register / Vol. 88, No. 25 / Tuesday, February 7, 2023 / Rules and Regulations - Pgs. 7875-7877.
