POSTAL RATE INCREASES SET FOR JANUARY 22, 2023

The USPS has received approval from the Postal Regulatory Commission (PRC) to implement postal rate changes effective Jan. 22, 2023. Proposed rate increases include a 3-cent increase in the price of a First-Class Mail Forever stamp from 60 cents to 63 cents.

There will be several mailing promotions available in 2023 to business mailers. Pre-approval requests will be accepted for promotions beginning on Jan. 9, 2023, at the USPS Business Customer Gateway. These proposed increases are in response to increased inflation and the rise in operating expenses and are being enacted to achieve the financial stability sought by the USPS's 10-year "Delivering for America" plan.
